Client Interviews

What Are Client Interviews?

Two competitors have as short amount of time to build rapport, understand the client's story and provide sound legal advice to the client

Basic Rules

Competitors are given 30 minutes to conduct a client interview

At any time, competitors can opt for a 5 minute break (the timer stops) to confer privately

After the interview, competitors have 10 minutes to reflect with the judge on their performance

- Ascertain relevant facts and legal issues Offer
- preliminary legal advice Maintain a professional
- working relationship

Mooting

What is Mooting?

Asimulated appealin a superior court, competitors are given a set of facts and decisions from the lower court and must argue whether this decision was correct.

Basic Rules

Teams of 2 or 3

Junior mooting for Years 1 and 2

Senior mooting for Years 3 and above

Teams will be judged on how well they know their information and how well they argue their points

- Complete a written submission containing a summary of your arguments
- Compete in an oral competition to deliver your arguments and respond to the judge's questions

Negotiations

What is Negotiations?

Negotiations is a mock mediation, involving a hypothetical factual scenario, where two parties are in dispute.

Basic Rules

Teams of 2

Competitors are provided with a set of 'general' and 'confidential' facts

Negotiations will occur for 30 minutes

Teams will have 5 to 10 minutes for reflection

- Negotiate an agreement to the dispute that satisfies your client's instructions
- . Identify your client's interests

Paper Presentations

What are Paper Presentations?

Competitors individually draft a written paper addressing a legal issue and present their paper to a panel of judges

Basic Rules

Accompanied by a 25 minute oral presentation

15 minutes speaking 10 minutes answering judges questions

Paper is approximately 3,000 to 5,000 words

- Explain your idea Persuade the audience
- to your viewpoint

Witness Examinations

What are Witness Examinations?

Simulating a trial, competitors provide accounts of the same incident whilst examing witnesses to support their arguments

Basic Rules

1 or 2 Barristers

Includes a non-competitive witness

Teams will be judged on their court etiquette and questioning

- Prepare your witness Elicit evidence
- Establish the credibility of your witness

GENERAL PRINCIPLES





General Rules

- 1.This document provides the rules, which shall govern participation in the Notre Dame Sydney Law Society ('the NDSLS') Competitions
- 2.The Competitions fall within the portfolio of the 'Competitions Director', who shall be responsible for the enforcement of these rules and the overall supervision of the competitions
 - a.all decisions of the Competitions Director are final unless otherwise specified in this document
- 3.Email 'competitions@ndsls.org' for any problems, queries or concerns
 - a.Similarly, correspondence should be via student (Notre Dame) emails. Any other source shall not be deemed as official
- 4.Competitions are run in accordance to the NDSLS rules competitors should familiarise themselves with these rules before competing

Competitor's Obligations

- 1.Participation in Competitions signifies an agreement to abide by the rules and guidelines set out within this document
- 2.Participation in the Competitions is open to all students currently enrolled in a 'Bachelor of Laws' at the University of Notre Dame Sydney Campus
- 3.In order to participate in the NDSLS Legal Skills
 Competitions, students must submit their
 registration to the Competitions in the method that
 the Competitions Director prescribes
 - a.Registration must be made through online forms.

 Should there be any issues please email

 'competitions@ndsls.org'
- 4.Registrations must be received by the allocated date.

 Acceptance of late entries will be at the discretion of the Competitions Director
- 5.In keeping with the professional expectations of the NDSLS, we request you comply with the guidelines of the Dress Code, observable at page 16

- 6.The Competitions Director reserves the right to disqualify any team or participant for:
 - a.A breach of the rules in this document
 - b.A breach of any University and/or Law School rules
 - c.Conduct that is not befitting to the competitions including, but not limited to:
 - i.Being late or failing to turn up to a competition;
 - ii. Failing to respect the authority or misleading judges or organisers;
 - iii.Failing to show suitable respect or misleading fellow competitors;
 - iv. Making a serious ethical violation
- 7.The preliminary decisions to the above are of the Competitions Director, however, the final decision resides in the joint agreement of the President of the NDSLS
- 8.Competitors are not permitted to use mobile phones during competitions, except as a timekeeping device.

 This must be made clear to the judge

- 9.Responsibility rests with the attending NDSLS members (presumed to be the Competitions Director or Assistant Director) for timekeeping and for adherence to allotted time periods and breaks.

 However, if resources and volunteers are available, timekeepers or timekeeping devices may be provided, but no individual associated with a participant may act as timekeeper in a competition involving such participant
- 10.The Competitions Director will be contactable via email: 'competitions@ndsls.org'

11.Once competitions have commenced, there shall be

- no modifications made to teams subject tot the
 Competition Director's discretion
 a.modifications to teams may be made at the latest
 24 hours prior to the nominated time for round
 one
 - b.For the Mooting competitions, modifications may be made to a team at the latest 24 hours propr to the submission of arguments

- 12. After 24 hours, a forfeit will automatically be applied and the team disqualified from the competitions
- 13.If a team is unable to participate in a particular round after the commencement of competitions, the team must forfeit, unless suitable arrangements can be made. This will depend on:
 - a.the availability of judges and venues;
 - b.the availability of the opposing team to reschedule;
 - c.the reason for inability to compete d.discretion of the Competitions Director
- 14. Whilst all attempts will be made, there is no guarantee or obligation placed on the Competitions Director

Observers Obligations

- 1.Observation of the Competition is encouraged, however potential for disruption must be minimised
- 2.No observer shall attempt to communicate in any way with any team members during competition

NDSLS Obligations

- 1. The competition's structure is set forth as:
 - a.All competitors compete in each preliminary round of the competition
 - b.The highest-ranking teams will advance to the next rounds
 - c.The remaining competitors are ranked on a reserve list according to scores
- 2.All decisions of judges in competitions are final. In the event of a tie, the aggregate scores will be used to make a final decision
- 3.Any concerns or appeals must be made initially to the Competitions Director
 - a.An appeal must be either administrative or equitable in nature
- 4.if a party wishes to compete in a competition representing the NDSLS, they first must get the permission of the Competitions Director and President of the Law Society

- 5. Subject to the discretion of the NDSLS, the winner(s) of the Competitions may be invited to represent the University of Notre Dame Sydney at the Australia Law Students Association Annual Conference (ALSA)6. The NDSLS is not under any circumstances obliged to invite a competitor to compete at ALSA
- 7.The Competitions Director and the NDSLS Executive may invite a runner-up or persons of high standard to compete at the ALSA conference.
- 8.All rules in this document are applied at the discretion of the NDSLS and may be edited, amended or applied in any way they see fit.
